

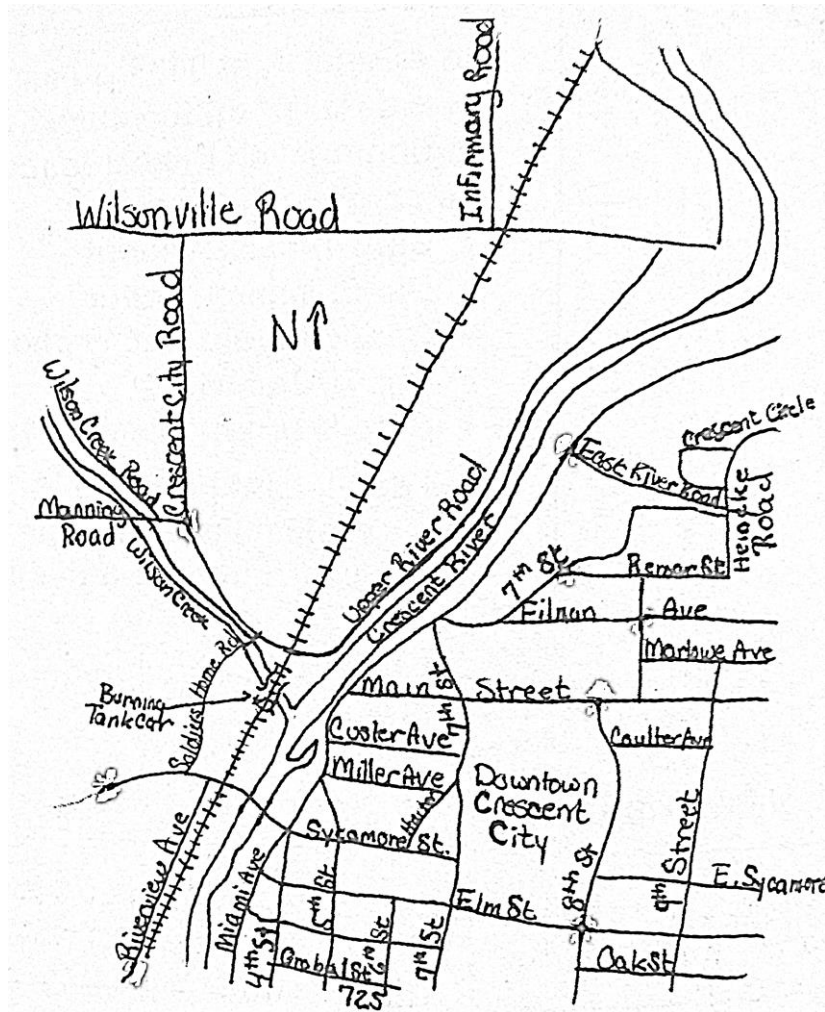

Situation Summary and Health and Safety Briefing (for briefings or transfer of command): Recognize potential incident Health and Safety Hazards and develop necessary measures (remove hazard, provide personal protective equipment, warn people of the hazard) to protect responders from those hazards.

Yellow Phosphorus is highly toxic by ingestion, inhalation and skin absorption. May be fatal. Corrosive to body tissues. Skin burns very possible. Avoid all body contact. Spontaneously combustible solid. Extremely flammable. **Fire Fighting Instructions:** Firefighters should wear PPE and SCBA with full face piece operated in positive pressure mode. **Molten Sulphur** is very toxic by inhalation. Harmful if swallowed. Irritating to eyes, respiratory system and skin. Avoid exposure. Do not breathe vapor or mist. Do not ingest. Do not get on skin or clothing. Avoid contact with eyes. Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers.

Critical Infrastructure: There is a 60 bed hospital at the NE corner of Sycamore and 7th St. The city EOC is at the NW corner of 8th St and Elm.

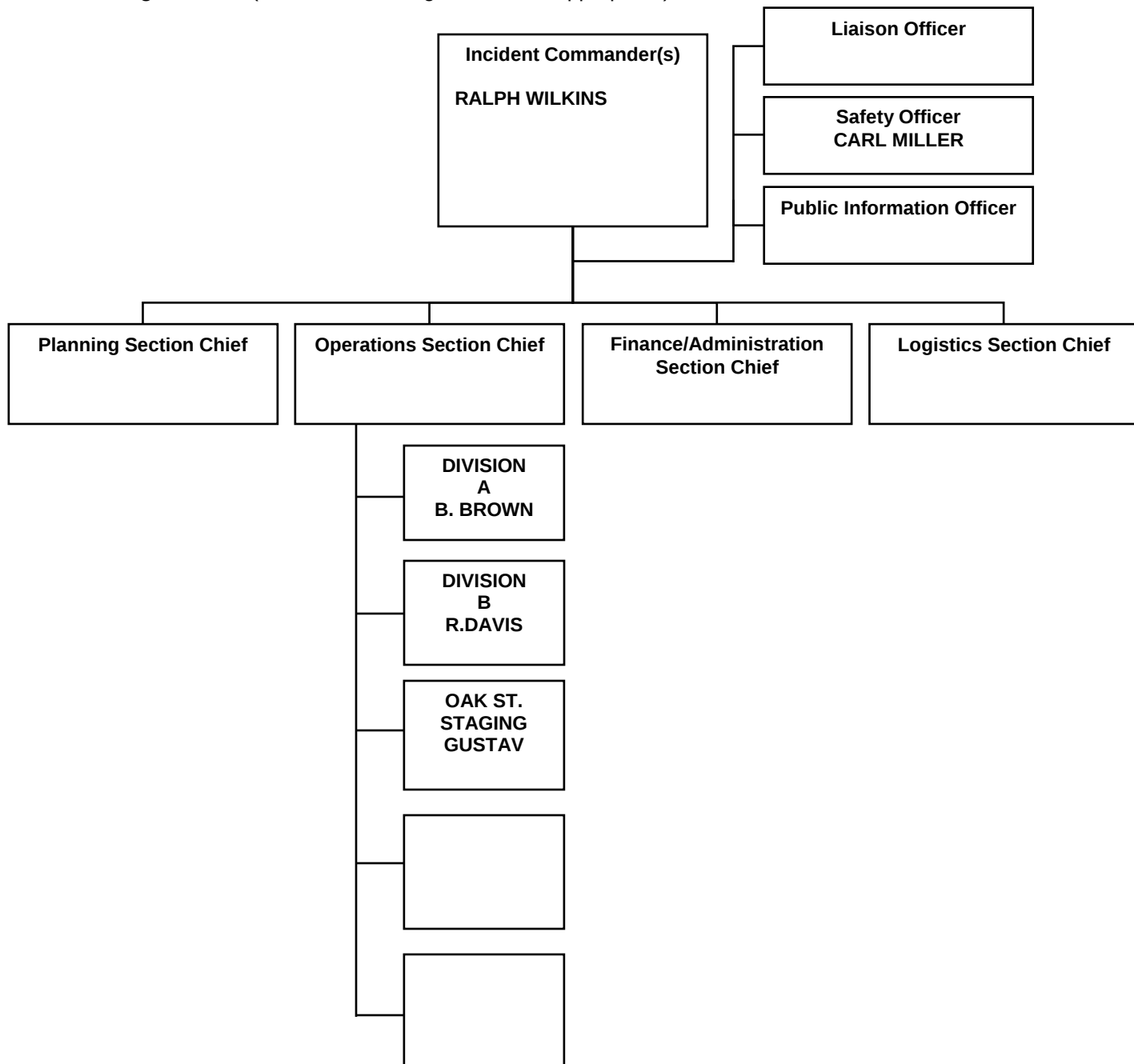
